BACKGROUND

The S.A. S.E.S. Volunteers' Association Incorporated (SASESVA), was established in the early 1990's, when SES volunteers felt there was a threat to their existence with consideration, in Government, being given to the amalgamation of the SES and the Country Fire Service, as a cost saving strategy. It was strongly felt that this amalgamation of these two uniquely different services would lead to the loss of service to the community. As a result, a committee was formed, a constitution developed and the association was registered with the Office of Consumer and Business Affairs on 31st December 1993.

The Association was subsequently recognised under the SA Fire and Emergency Services Act 2005 and then again in June 2008 with the signing of the first Volunteer Charter. (Section 123) of the Act states:

- S.A.S.E.S. Volunteers' Association Incorporated is recognised as an association that represents the interests of members of SASES Units.
- The association may take such steps as may be reasonably available to advance the interests of members of SASES Units.

In 2013 the NSESVA was established and the Chair represents SA on this group, works and lobbies on the national level.

In 2016 the Association was also registered under the Australian Charities and Not-for-profit Commission.
